NEW BOARD BUSINESS

80 Main Street – Illegal dumping – Update

The chairman updated the Board regarding the sighting of an employee, for the establishment located at 80 Main Street, illegally dumping waste from a catch basin onto the ground. Chairman Zalewski, asked the employee to stop and with no resolution Mr. Zalewski reported his sighting to the Health Director. A cease and desist was given by the Fire Department and the Health Director called the Department of Environmental Protection. The establishment was ordered cleanup of the illegal waste and a manifest was provided to the Board of Health by the company who performed the cleanup. The soil that was contaminated by the waste was not removed and pictures were taken by the Health Director of this and submitted to the Department of Environmental Protection. The Department of Environmental Protection stated they were satisfied with cleanup and manifest.

OLD BOARD BUSINESS

Review of proposed Nail Salon Regulations and Guidelines (discussion only)

The Board recognized that the Nail Regulations are still in a rough draft form. Member, Matthew Wyke, raised some concern that part of the regulation excuses 4 or less seats and he believes that it should be across the board of all nail or nail and hair salons. A motion was made to potentially make a change to the Nail Regulations. Vice Chairman, Iwona Miller, mentioned that she contacted the Department of Public Health and slowly proposed Nail Regulations will be put into effect with less time to comply with the regulations, compared to the Local Board implementing these regulations.
