

RE: Multiple search warrants executed in Webster and Dudley

On November 24th at approximately 5am, members of the Webster and Dudley Police Departments executed several search warrants as the result of a several month long investigation conducted by the two agencies. Assisting them in serving these search warrants were members of the South Worcester County Counter Crime and Drug Task Force which includes Charlton, Oxford, and Southbridge Police Departments, as well as the HIDTA DEA Task Force located out of Worcester. Also utilized was the Central Massachusetts Law Enforcement Council (CEMLEC) SWAT team.

Juan Robles, (54, 8 Village Way #4 Webster) was arrested and charged with Possession of a Class A substance with the intent to distribute, as well as two counts of Reckless Endangerment of a child. The children were turned over to the Department of Children and Families.

At 8 Crown Street #2M in Webster Paige Bilodeau (21), and John Reznikow (21) were arrested and charged with Possession of a Stun Gun, Possession of a Class B Substance with the intent to distribute, Possession of a Class E Substance with the intent to distribute, and Possession of a Class C Substance with the intent to distribute. Several hundred dollars in cash was also seized by detectives at the scene.

At 4 Sanger Street in Dudley, Matthew Paschopolous (31) was charged with Possession of a Class A Substance and Possession of a Class A Substance with the intent to Distribute. Detectives seized \$1,500 from his residence.

At 8 Chestnut #2L Street in Dudley, Maritza Colon Mueller (34) and Sheri Keener (41) arrested on warrants for Distribution of a Class A Substance, Possession of a Class A Substance with the intent to distribute, and Conspiracy to violate the

controlled substance law. Also arrested at the scene was Ricardo Rordriguez (38, same address) for Disorderly Conduct and Disturbing the Peace.

At 8 Day Street, 1L, Jose Lopez was arrested and charged with Possession of a Class D Substance, Possession of a Class D Substance with the intent to distribute, and Violation of a narcotics law near a school or park. This address is right next door to St. Anne's School which hosts grades 1-8. It was the site of a previous narcotics search warrant back in April of 2014.

Also arrested were Shawnte Foston (23 16 Village Way, #4) on an arrest warrant for Distribution of a Class B Substance and Possession of a Class B Substance.

Alan Kepulka (41, 6 May St 1st flr.) was arrested on several outstanding arrest warrants and Possession of a Class A Substance.

It is not believed that any of the above listed individuals operated together, but rather each was their own enterprise. All parties, with the exception of Lopez, Billodeau, and Reznakow, were arraigned at the Dudley District Court. Lopez, Billodeau, and Reznakow will be held at the Webster Police Department pending release on bail later on today.


