Chairman Miller asked if there were any other nominations for Vice-Chair. Hearing none, Selectman Miller closed the nominations for Vice-Chair. He asked for a motion on the candidates.

Chairman Miller opened the floor to nomination for Secretary.

Motion: made by Selectman Starzec, seconded by Selectman Dowgiewicz to nominate Selectman Jolda as Secretary.

Motion: made by Selectman Starzec, seconded by Selectman Dowgiewicz to appoint Selectman Starzec as Board Secretary of the Board of Selectman.

Vote: Selectman Jolda – yes, Selectman Bourque –yes, Selectman Dowgiewicz – yes, Selectman Starzec –yes, Selectman Miller – yes.

Chairman Miller stated the Board received a copy of a Town Meeting Petition dated Monday, April 28, 2014. Mr. McAuliffe stated the Board has fourteen (14) days to forward the petition to the Planning Board for review.
