May 20, 2021

#### Meeting called to order 5:00 pm

Roll call was conducted to hold a recess until 5:30.

#### Meeting reconvened at 5:30

The following individuals were in attendance via remote: Chairwoman Janet Stoica, Vice Chairwoman Iwona Miller, Member James Avery, Member Matthew Wyke, Member Anne Violette (to witness), Special Town Council Brian Winner, Bruce Haskell Langdon Environmental (BOH consult), Tim Ryan (owner), Kristen Engberg, George Hailer Esq. (applicant council), Sam Butcher Loureiro Environmental (applicant's engineer) and BOH Clerk Jenny Szubra.

Ms. Stoica stated, pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L.c.30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Webster Board of Health will be conducted via remote participation to the greatest extent possible.

#### **Agenda**

#### **United Medical Waste Management, Inc., 56-65 Rd. – Consideration of Site Assignment Modification Decision**

Confirmation that the proposed Site Assignment Modification was reviewed by all Board Members.

Atty. Winner reviewed reason for tonight's meeting. He discussed prior hearing regarding United Medical, from that hearing it is required that a written Decision of Findings needs to be voted on within 45 days from Public Hearing which was held March 1, 2021. He stated that the Towns Engineering consultant Mr. Haskell reviewed and commented on this Decision along with United Medical's Council and Engineer. Atty. Winner explained that if all criteria has been met then it should be approved, the only reason to deny is if there is substantial basis to believe that the site would impair or endanger Public Health safety and welfare and be detrimental to the environment. The evidence given and criteria that is needed to be met shows that there is no Public Health and safety issues or any environmental detriment. Atty. Winner respectfully requested that the Board review the decision and discuss any comments, concerns or

questions. Atty. Winner shared the document live and noted all changes that were asked to be made to the Decision by applicants engineer and or Attorney.

Atty. Winner and Mr. Haskell discussed and approved any and all changes that were made by applicants Engineer. It was noted that all changes were minor.

Atty. Hailer thanked the Board of Health and Town Council for staying on top of the application during this COVID crisis and it's much appreciated and recognized the diligence of what was needed to hold this hearing and Decision.

**Mr. Avery moved to accept the draft decision that was reviewed and discussed by the Board this evening as the final decision of findings and conditions.**
